# TERMS AND CONDITIONS

## 1. OBJECT OF THE INSCRIPTION.

With this registration form the student or his legal representative (following: the STUDENT) herewith books the INTERNATIONAL SUMMER CAMP. This course will be organized by LA PLAYA ESCUELA DE ESPAÑOL S.L. (following: the CENTER).

## 2. PRICE OF THE COURSE.

The final price of the course as stated on the proforma invoice correlates with the information about the offered courses published on the website of the CENTER.

## 3. START OF THE COURSE.

The course starts on the day stated on the proforma invoice.

The classes will be taught according to the schedule communicated in the confirmation of the booking.

## 4. PAYMENT AND PAYMENT DELAY.

25% of the total price stated on the proforma invoice has to be paid in advance at the moment of the reservation of the course within 14 days after proforma invoice date unless another agreement between STUDENT and CENTER has been made (eg. last-minute registrations). The missing 75% of the total price will be paid at the latest on the first course day.

The payments can be done in cash, with credit card, *PayPal* or by bank transfer to LA PLAYA ESCUELA DE ESPAÑOL, S.L., with the bank account of the bank UNICAJA: ES08 2103 3032 56 0030019887, indicating as a concept course type and the name of the person who will do the course.

If the payment is not realized in the mentioned period, the CENTER can declare the STUDENT in delay. In this case, the STUDENT has to indemnify the CENTER with the corresponding payment which might be adjusted to the legal interests of the corresponding date.

## 5. CANCELLATION, DELAYS, DEVOLUTION, NO-SHOW.

- In case that the STUDENT cannot assist the classes because of reasons not caused by the CENTER, the STUDENT has no right to be indemnized by the CENTER and the class cannot be recovered.
- In case that the class cannot be taught because of reasons caused by the CENTER, the class will be recovered according to the agreement between CENTER and STUDENT.
- The cancellation has to be done in a written form.
- For cancellations made more than 30 days before the start of the course, the already paid amount except for the inscription fee will be reimbursed.
- For cancellations made between 15 and 30 days before the start of the course, 50% of the already paid amount except for the inscription fee will be reimbursed.
- For cancellations made less than 15 days before the start of the course, no refunds will be made.
- In case of renouncement, delay in arrival or not assisting the course, no reimbursement will be made except for special cases. In case of special circumstances, the CENTER decides if a reimbursement will be made.
- The CENTER reserves the right to ask the STUDENT to leave the school in case of very inappropriate behavior. In this case no reimbursement will be made.
